# OFFICIAL CONVENTION MINUTES OF THE 52ND ANNUAL DISTRICT CONVENTION -- GOLDEN GATE DISTRICT NO. 21 - ORDER OF AHEPA FRIDAY

#### JULY 6, 1984

The opending session of the 52nd Annual District Convention of the Order of Ahepa was called to order by Chairman of the Convention, Chris Rockas, at 11:00 o'clock a.m. on Friday, July 6, 1984 at the Holiday Inn in Fresno, California, welcoming the Daughters, Maids, and Sons.

After the pledge of allegiance to the flag, the invocation was then given by District Chaplain, Nick Alevizos.

The Officers of the Ahepa Family seated at the main table were introduced.

Helen Rockas introduced Councilwoman Karen Humphrey who rendered the welcoming remarks on behalf of the Mayor of Fresno.

Co-Chairman, Bill Booras and John LaBritt, also welcomed the Delegates.

District Governor George Marmas spoke on "Locking Ahead for the Future" and congratulated the Fresno Chapter for hosting the District Convention. At this time he introduced his District Lodge Officers.

Governor Marmas also introduced the Daughters of Penelope Governor, Irene Margelos who thanked Fresno for hosting the Convention.

District Governor Irene Margelos introduced her District Lodge, Maids of Athens, District Governor Tina Chicos and introduced the Grand Vice-President, Thaila Banis who welcomed the Delegates.

The gathering was recessed at 11:30 o'clock a.m. and at 11:45 o'clock the official meeting of the Order of Ahepa District #21 reconvened by District Governor George Marmas for the purpose of selecting a convention Chairman, Vice-Chairman and Convention Secretary for the business sessions.

George Marams also announced that there were 40 registered Delegates present. At this time he also appointed the Credential Committee: Dino Alexander; Stratis Zampathas, Chairman; and Louis Colombotos. Tellers appointed by the District Governor: Bill Leos from San Jose and Bill Kogeones from Modesto. Recognized by the District Governor, George Marmas were visiting Brothers of the Order of Ahepa who were George Zam, 1st President of Sacramento Chapter; Andrew Rotous, Aberdene, Washington, 179-District 22; and John Kaplanis, visiting Brother from Clearwater, Florida.

Nominations were opened for Convention Chairman: Bill Rotas nominated Lou Janakos for Convention Chairman, seconded by Gust Aretos. There being no further nominations, the Delegates unanimously selected Lou Janakos as Convention Chairman for the 52nd Annual District Convention for 1984.

Angelo Mountanos was nominated for Convention Vice Chairman, Paul Eliopoulos, seconded by Connie Orfanos. There being no other names placed in nomination, the Delegates unanimously elected Paul Eliopoulos as Vice-Chairman.

Spiron Tentes nominated George J. Kartinos, seconded by Peter Papageorge for Convention Secretary. There being no other nominations, George J.

Kartinos was unanimously drafted to be Convention Secretary.

The above named elected officers were duly sworn by District Governor George Marmas.

The meeting was adjourned at 12:10 to attend the luncheon with all of the other Delegates, Daughters, Sons and Maids.

The Chairman called for reports from the Delegates: Angelo Mountanas reported on the Annual Chairtable Raffle which was to be submitted to the Daughters for their approval.

A fund raising idea was presented to the group for discussion and approval to be taken back to the Daughters to see how they react to it. This has to do with fund raising in the District and ties up with Saint Nicholas Ranch Project. Saint Nicholas project was created in an effort to project Ahepa among our Greek communities as being a service organization. As you know, there isnot much more for Ahepa to do but be a service organization at this particular stage in the life of Ahepa. It is going nationally and filtering down to us. I am going to read the proposal but I think you

should discuss it at length after it comes back from the Daughters, if they approve, because they may have changes. They may want this, or they may scrub the whole thing, so why waste time until we hear back from them. It has been suggested that an annual charitables project raffle of Golden Gate District #21 of the Order of Ahepa and Daughters of Penelope be established. We have tried testimonial dinners in the past but have found that the costs are so high htere is nothing left to come back into the kitty. That is why we have devised something like this. Some of the Chapters have run individual raffles that have been much more successful than with the testimonial dinners.

It is strongly urged by the Advisory Board of Golden Gate District #21 that an Annual Charitable Project be established at this District Convention, with the Daughters of Penelope as participants. The prizes will be raffled at the District Convention Banquet, starting with the District Convention of 1985.

There will be 2000 tickets issued at \$100 each. The prizes will be as follows:

1st prize \$50,000 2nd prize \$20,000 3rd prize \$10,000 and 19 prizes of \$1,000 each.

First number drawn will be the grand winner.

Total prizes \$99,000, \$1,000 to be used for expenses, profit \$100,000.

The first year, all profits will be used for the completion of the Ahepa Building at the St. Nicholas Ranch. The second year all profits will be given to the Daughters of Penelope, so that they may complete a project at St. Nicholas Ranch. Thereafter the profits will be distributed equally to charities designated by the Order of Ahepa and Daughters of Penelope of Golden Gate District #21. The profit will only be used for charitable projects in District #21. District Convention delegates to decide on distribution of the funds, one year in advance.

A separate committee will be formed to administer this annual projects raffle. The respective District Governors will automatically be ex-officio members and they will appoint 4 members from each respective lodge to administer this project each year. Besides the eight members,, a chairman will be appointed each year by the respective District Governors. Each year the chairman will rotate between the Ahepas and Duaghters of Penelope.

District Legal Counsel to be used to work out all legal details of the mechanics of the raffle.

It is suggested that the first year the appointed chairman be Gus Aretas, who has been instrumental in conceiving the establishment of a charitable projects raffle. It was his idea at one of the District Lodge meetings. He had gotten this idea from a raffle that exists back East in one of the churches. This is what we would like to propose.

This is a tough project and that is why everyone has to agree to it or it will never work. This has been suggested and I bring it before you. With

your approval I would like to take it to the Daughters and then bring it back and have you discuss it with any changes they might have. It was decided by the group to present it to the Daughters.



#### For The Good of the Order - Sam Dakis

Yesterday there was a misunderstanding regarding the credentials. I do not know if I have to apologize but I will apologize to the Delegates. My assumption was, that when we come here to Fresno to approve the convention, my understanding was, from the Chairman of this convention, upon receipt of all the forms from the Delegates on 6-1-84 to send originals to General Chairman and keep copies for myself. No one told me that I was supposed to compile all the names of Delegates and alternates, Past District Governors and the members of the District Lodge. Brother Bill Rotas toldme what the Constitution said my duties were. I stayed up all night long to do this. I am sorry it is late.

#### Audit Report - Bill Rotos

Audit of activities began June 22, 1984. I verified the income and expenditures into the District Lodge as well as the income and expenditures through the District Scholarship program and the income and expenses for the 1983 Convention. We have a cut-off date of May 31st, however from May 31 to July 6, we checked the books on the June 27th and a total of 20% of our total income from per capita tax has come into the District Lodge from the time that I checked the books on June 27th until I finished at 4:00 a.m. on July 6th. Brothers, we have a problem. The problem exists in that the Chapters are negligent in submitting per capita tax payments. The District Lodge Officers are negligent in not transmitting the payments to the District Treasurer on a timely basis. Also, this presents other problems in developing our total membership within the District. As of the date of the audit, prior to the additional income that came in, we had a total of 655 members paid for 1984. From the time of the audit till the time i'm closing my report, we now have 855 members per capita tax for 1984, plus 119 members per capita tax for 1983. What this points out is that 20% of our income comes in the last two weeks of our calendar year, not our fiscal year. Because of this it has been difficult to reconcile our membership payments of our per capita tax submitted to the District Lodge and the per capita tax reimbursements from the Supreme Lodge. In case you are not aware, when you send the Chapter Secretary \$15.50 per member into the Supreme Lodge, a portion of that comes back to the District Lodge in the form of a rebate of per capita tax. That amount of money is paid to the Districts on a 6 month period. That 6 month period does not coincide with the calendar year but the fiscal year that we operate on. Our dues are paid on a calendar year and our audit goes on a fiscal year. Therefore, it defies gravity to try to figure out just how many members we have at any one time in District 21. On the basis of my audit report and the verification that I did, we have as of this morning 855 members paid for 1984. Because of the problem of recording the payments of per capita tax, both at the District and National level, another problem is presenting itself. District Secretaries will submit a payment of per capita tax to the Supreme Lodge and for whatever reason exists, they do not get around to paying the District Lodge or they are late in transmitting the per capita to the District Lodge. We have been talking to several members on the Budget Committee. We also have some things coming in on a possible use of a computer but basically, the basic input document is what we are making a proposal that we submit to the Supreme Lodge a change in their process. At the present time Supreme Lodge sends a form back to the Secretaries which is a 3 part form. We are proposing that this is a 4 part form so that when the Chapter Secretary collects its per capita tax, he fills out the form, attaches the amount of money he is going to send, tears off the 2 copies that go to the Supreme Lodge and send those in, tears off his copy for his file, he has one copy left which he sends to the District Secretary. If this was done at the Supreme level, and we are going to pursue this in the form of a recommendation, to our District Governor to ake to the National Convention, we would not have the problem of delayed er capita tax coming into the District. The District Convention for 1983 as run by District 21 of Ahepa and Daughters of Penelope. As a result of hat operation, total income was received of \$14,825.88. Totoal expenses efore profit sharing was \$13,480.67, or a gross profit of \$1,345.21. If you will recall at the time that the District Convention was initiated by the District Governor, the statement was made that those Chapters that send in adds for the Traveler and adds for the Convention Book. The Chapters that had the greatest percentage of adds would realize a percentage return to their Chapter treasury. So in distributing \$1,345.21, Stockton Chapter received \$60.00 of its advertisement sales. San Mateo received \$48.00, the alance was divided between the District Lodge of the Daughters and the District Lodge of Ahepa and each received \$618.00. A total of \$1,345.21. The records of the District Convention were in excellent order and we should commend the District Treasure for monitoring the records as well as he did on that activity. On May 17th, the Scholarship Committee transferred the monies that were in a savings account that were locked up, and placed them in these long term security accounts, there was some prepayment penalities. The penalities amounted to \$1,522, however, the two savings accounts that are the main corps of the Trust Fund of the Scholarship Committee, one in the amount of \$24,369 at the 11.85% for one year will realize \$3,065 in interest. This same account when it was invested at the 9.7% rate would have realized \$2,130 or a net gain of interest of \$934.51. Prepayment penalty on this one was \$582 so at the end of one year from now Je will have recovered that \$351. The second account which is \$39,250, at 1.85% interest for one yar will earn \$4,937. This same account with the old investment at 9.7% or \$3,755, the net gain is \$1,182. Prepayment penalty was \$938. Again, we will realize \$243. I'm pointing this out so you will see that the Scholarship Committee has very prudently managed the trust funds instrusted to them for the treatment of the Scholarship program. I think, Brothers, that this is a program that we should be proud of and the fact that the Scholarship Committee is very conciencious and prudent in their management of these trust funds. I have provided a schedule of activities to the District Secretary. I will read just the totals. May 31, 1984: Checking \$3,360.29. Savings \$9,640.48. July 6, 1984: Checking \$1,348. Savings \$11,229, and Money Market Fund \$2,500. The District Lodge has aga a moved its money around in a prodent manner to the point where the District operations for 83-84 have actually operated at a surplus. We had total amount of income related to our budget of \$4,864. We had operational expenses of \$3,793. We spent \$3,977 so the Traveler Fund went in the hole \$183.29. Again, when you combine the two of them we still wound up with a surplus of \$1,000. The District Lodge has seen fit to reimburse the savings account the \$1,000 that they had transferred two years ago and in addition to that they transferred another \$1,500 from a checking account to a savings account. There is one item of accounts receivable for the Traveler Fund and that is the \$900 assessment to the Daughters of Penelope District Lodge. That usually does not come in until the close of the District Convention. That is receivable but we have not received it as yet. The District did not have a raffle this year to raise any funds for the Traveler and this was because of several reasons that existed, basically time did not permit a raffle. At this point, this is the result of the audit report for the District. It was unanimously moved for adoption.

#### Legislative Dinner - Bill Rotas

This is a program adopted at our Convention last year. Sacramento Chapter is the host for the activity but it is a District-wide dinner that will be held in January 28, 1985. I'm sorry Paul Christo blos is not hear to give you a more detailed report as he has been handling it on behalf of Sacramento Chapter and District 21. Board of Supervisors, represented by Bill Rotas, unanimously moved for its adoption with certain reservations. (Passed).

#### Grievance Committee - Gust Aretos

- 1. First grievance was that the Convention should start on Friday at 9:00 a.m. with a break at 11:30 a.m. for formal opening ceremonies. This recommendation was made by the women.
- 2. Scholarship Committee announced the winners too late. They would like some kind of guidelines for the Scholarship Committee to announce the winners 30 days before the convention because some people go on vacation and this has caused a problems.
- 3. From the Maids of Athena. That they were not allowed to register until 1:00 p.m. and that does not give them enough time to complete their business.

#### Board of Advisors - Gust Aretos

Over the years we have been called many things but we have been known as the Past District Governor's Service Club of District 21. We have been called the Board of Directors and now, the most recent title change based on National recommendations, the Board of Advisors. For those of you that are not aware, about 25 years ago, District 21 Past District Governors formed what was called a Past District Governor's Service Club. Not with the intention of running the District Lodge, because the District Lodge has to do their own thing and they have to do their own managment of the District, but it was organized with the idea that at some point in time this wealth of experience from all of the Past District Governors would be tapped and used to assist the District Governor and Disttrict Lodge in performance of their duty. Sons of Pericles, boulster up a Lodge, etc., were some of the things this group would do. Three years ago in Atlanta, Georgia, the Board of Directors was adopted by the Supreme Lodge at the National Convention which consisted of Past Supreme Presidents in the same kind of activity we had been doing for 25 years in District 21. It has now evolved to the point where the Supreme Lodge says you will have a Board of Advisors within the District and they will offer their services to the District and to the District Lodge. In that capacity, I am reporting for the Board of Advisors. We met last night, it was a short meeting. We started a little after 12:00 midnight and finished at 4:00 a.m. this morning. The discussion revolved around 5 suggested recommendations that the District Governor is going to make in his report. These are: (1) Rules and regulations on how to select a Chapter of the Year. The Board of Advisors have come up with the following criteria for the District Lodge to use in selecting an Ahepa Chapter of the Year. (a) To consider a percentage of increase in membership; (b) Regardless of the size of the Chapter, the conduct of their meetings and attendance at their meetings. Are they meeting on a regular basis. Do they send out motifications to their membership. Do they have a fully constituted quorum meeting. the minutes maintained. Do the officers follow the ritual or do they just have a general get together session. Do they follow the rules of protocol. (c) How well does the Chapter participate in National and District projects. For example. do they assist in raising funds for the scholarship program. Are they active in raising money for the Saint Nicholas program. Have they gotten on the band wagon for the Save the Liberty Project. Has that Chapter been so inovative that they have had unusual and unique activities in their structure. These are the items to be evaluated by the District Lodge. What kind of guidelines should be used in selecting a convention city? (1) The city that requests a convention should submit to the Convention Committee a packet which contains a letter from a hotel, a letter from the

Chamber of Commerce, a letter from the City officials. In otherwords, we want to know whether we are going to be welcome in that particular city. (2) They should attempt to obtain rates from a hotel. We want to know what it is going to cost us. (3) They are seeking a convention, two years away.

- #2 The Board of Advisors also considered the matter of the recommendation of the District Governor that all recommendations passed on the Convention floor should be followed up by the Past District Governors and we said "no". That is the job of the District Lodge. The District Governor has been elected by the Convention Body, he has 5 officers on the District Lodge plus one or two appointed officers. He has the Board of Advisors available to him at anytime and it is his responsibility to followup on any convention mandates that are acted upon by the Convention floor.
- #3 A Fall seminar where the Past District Governors have a training session with all new Chapter Officers. We wholeheartedly support this concept. We have participated in 2 seminars in the last 2 years and feel they are very helpful. We are wholely and totally committed in instructing our new officers in the operations and conduct of their office at a Chapter level.
- #4 Books of all Chapters should be simplified such as Secretary and Treasurer. The Board of Advisors said take a look at the National Headquarters. They have an accounting system already established for each Chapter. Why not use that? It is a standard accounting system. It is simple and we feel the District Lodge has a responsibility when they go to make their visitation that they should look at these things. The District Lodge should take a look at what the Chapter is doing. Are they conducting their meetings properly? Are they doing the normal operations as written up in our manual? If this is the case then they are automatically following a simplified set of books. If they are not then it is up to the District Lodge, as a responsibility for them, to see that the Chapters adhere to the book of rules.
- #5 In place of a formal visitation with the exception of installations and initiations, break up the District Lodge into a strong liaison unit with each District Lodge officer responsible for 2 Chapters. He must visit each Chapter at least 3 times with a written report to the District Governor. One visit will be made with the District Governor and the other 2 with 2 Past District Governors. More work can be accomplished on a oneto-one relationship instead of a formal visitation. District Governor is suggesting that Past District Governors be put back into harness and work with the District Lodge on a one-to-one basis. Our group felt that the concept is excellent, however, it is up to the District Lodge and District Governor to run his District. It is up to him to select and appoint people to go to the Chapters that he feels needs assistance. However, if he does feel he needs help from us, we are here and we are available. It is not up to us to appoint anyone to act in that capacity. As far as the District Lodge conducting themselves in meetings, we suggest that the District Lodge on its selection as an officer of the District Lodge do several things: (1) Make himself knowledgeable of the current constitution. (2) That an officer of a District Lodge, no matter how many times he has served, either at the Chapter level or District level, must make himself knowledgeable of the ritual, the Manual of Public Ceremonies and the Manual of Protocol. There are three books every District Lodge officer must have a copy of, and must follow it. We further suggest that when the District Lodge officers

appears at any function, which includes the opening of the District Convention, as well as a visitation to a Chapter, he must appear as a District Officer. He must appear in his uniform, his jewel and his fez if he has one. Some District Lodges wear them, some don't. When they come into the meeting hall the Chairman of the meeting must recognize the District Governor of the District Lodge for their position. They are the leaders of the District Lodge and we must give them the respect. We feel this time that we remind you of these things.

Around the first part of May all the Chapters within the Ahepa domain receive a letter from the Supreme Lodge. Along with it was a copy of a letter that was issued by the Archbishop. This letter said, henceforth from now on into the future, the first Sunday in May will be known as Ahepa Day. The action to adopt that concept was taken by the Supreme Lodge and Archdiecese early in January of last year. Notification was not issued until along about the end of April or first part of May. Almost to the point that notification is here and the event is to take place tomorrow. We suggest that they make this a must item on their agenda. That they must contact each Chapter, and each Chapter in turn must contact the Parish Council and the Parish Council the Parish Priest and remind them of this mandate from the Archbishop and the mixed Council that the first Sunday in May will be known as Ahepa In our District, District 21, about 50% of the Chapters had such an activity and about 50% did not because the letter was late in getting to either the Chapter President or to the Parish. That, Brothers, is the conclusion of the discussion. The Board of Advisors stands ready, willing and able to serve the District in any capacity should the District Governor of the District Lodge ask us to.

M/S/C to adopt this report except for item #2 that the Past Governor's could not support.

#### Sons of Pericles - Andy Banis

The Sons of Pericles of our District #21 have shown a growth pattern that we have been looking for. For example, the membership in 1982 (86), 1983 (97), 1984 (110). Note the growth is constant and over 10% per year. There are five active Chapters, San Francisco, Oakland, Sacramento, San Jose, San Mateo. I would like to acknowledge the fine work and support of Harry Haramalis and our District Governor, George Marmas gave to our Sons of Pericles. The Budget has been presented to the Budget Committee and does require our support. Our Jr. Orders have a publication "La Nia" which is published (4) times a year, this publication has been well received within the District and is an example of the fine and continuing work by our sons and Maids. Thank you for the opportunity to serve the District Convention in this capacity.

At this time the officers of the Sons of Pericles were introduced. Also, introduced was the Supreme Vice-President of the Sons of Pericles, Peter Bissias from Los Angeles, who spoke.

#### District Governor of the Sons of Pericles - Andrew Ganetsos

On behalf of my District, I would like to thank you for your support this past year. Special thanks to District Governor, George Marmas and our Advisor, Harry Haramalis. As the figures show, we have increased our membership by 10%. We have been very successful with our District publication Ta Nea which we had 4 issues published this year. We have also initiated

36 new members within the District. During my term I have made many visitations. I have visited 2 times to e-ch Chapter and there is a long distance between these cities and we can really use the Ahepas' help for traveling expenses. The Sons of Pericles ask for your continued support of our endeavors so that we can continue to serve the Ahepa family as a whole. At this time I am going to ask the Supreme Vice President of the Sons, Peter Bissias to say a few words.

#### Supreme Vice President of the Sons of Pericles - Pet r Bissias

I am here as an observer. I am their National Liaison Officer. My capacity is not to come here and lobby for their benefit. That is the responsibility and decision of the Golden Gate Ahepa District. As Mr. Panis said, they do have a lot of needs for their programs and for the functioning of their District throughout the year. We are talking about monetary needs. They are going to present their budget to you and ask for your support and your help in helping them achieve their plans for this year. As Mr. Banis said, they have had increased membership over the previous year. I would also like to say that the Sons of Pericles in this District supported the Sons' National Project, the Special Olympics with a monetary donation. They also started the San Jose Sons of Pericles, a new Chapter, in your District this year and also, please consider this is the year, this February, when District 21 is the host district of the Western Regional Basketball Tournament of the Sons and Maids. The site is still to be determined. They also have their Ta Nea newsletter which is something that gives the kids an opportunity to communicate amongst themselves over the vast area of this District and the basketball tournament which gives the kids an opportunity to meet each other from the different Districts as well as an opportunity to participate in the tournament. I ask you to please consider their needs when you are discussing the Sons of Pericles in your business session and not only have the Sons in this District increase their membership but also the Sons Nationally. Our membership this year will top over 2400 members which is the highest membership we have had since about the 1940's. In closing, I would like to thank you for the opportunity to come before you and speak and deliver my message.

#### Athletic Committee > Bill Kogeones

The Committee met at 8:45 a.m. this morning. The following Brothers were present: Ernie Kageones, Steve Panos, John Koplos and George Marmas. The following recommendations were made: (1) That the Delegate Luncheon be considered for the presentation of an athletic award under the direction of the District Lodge. (2) Propose athletic events such as golf, bowling and other events at the discretion of the Convention City Committee. (3) Inter-Chapter sporting activities with play-offs at the Convention City. (4) Awards will be paid through an entry fee of the participants. At this time I move for the adoption of this report.

Next year's convention will be held in the City of Burlingame in San Mateo County. We are going to have it at the Clarion Hotel and we have planned a very good convention for you. We managed to get a very reasonable room rate, they are going to run between \$42-\$45 for a double. We are going to have a cocktail party every night 2 hours long, given by the hotel. Room rents include breakfast. They have a brand new facility. There is

a swimming pool, they have been in touch with Marine World to put something together for the young people. We have a tentative spot where the teenagers are going to be able to hold a dance outside the hotel which will give them that sense of freedom they all seem to want and its in an area they won't have to go on the freeway to get there. San Nateo County has been working very hard getting our preparations together and we are all eady to go forward with it in 1985 and we are all looking forward to seeing you there and hope you will support us there as well as you have supported Fresno here.

#### For the Good of the Order - Gus Zakos

am going to report on the Saint Nicholas kanch. It seems it has been a whole year since they adopted the resolution for the ranch and the only monies that have been turned over to the Committee is \$17,000. San Jose has given \$11,000 and San Francisco \$6,000. I have at this time a check which we have raised for \$2,000 which I am going to turn over to the Vice-Chairman, Paul Eliopoulos. Part of the share of \$3,500.

Further short remarks by the Chairman of the Convention. At 11:52 the Chairman declared adjournment to 1:00 p.m.

#### Afternoon Session

At 1:20 p.m., Chairman Janakos called the session to order. At this time there were 63 who were present. Liaison Committee report was made by Angelo Mountanos after consultation with the Daughers regarding the Joint Charitable Project.

#### <u> Liaison Committee - Angelo Mountaes</u>

Annual Charitable Raffle - Ahepa and Daughers of Penelope. I am going to read it to you and tell you how the Daughers would like to have it. It is strongly urged by the District 21 that an annual charitable project raffle be established at this District Convention with the Daughters of renelope as participaants. The prizes will be drawn at the District Convention Banquet starting with the District Convention of 1985. There will be 2,000 tickets issued at \$100 each. First prize \$50,000, 2nd prize \$20,000, 3rd prize \$10,000 and 19 prizes at \$1,000 each. First number drawn will be the grand winner. Total prizes \$99,000. \$1,000 to be used for expenses. Profit\$\doldow{0}00,000. This is what I took to the Daughters and I will come back and give you the changes. The first year, all profits will be used for the Ahepas building at Saint Nicholas Kanch. The second year all profits will be given to the Daughters of Penelope so they may emoplete their project at Saint Nicholas Ranch if they undertake one. Thereafter, the profits will be distributed equally designated by the Order of Ahepa, Daughters of Penelope; District 21. District Delegates to decide on distribution of funds one year in advance. A separate Committee will be fored to administer this annual projects raffle and respective District Governors will automatically be ex-officio members and they will appoint 4 members from each respective Lodge to administer this project each year. Besides the 8 members, a Chair will be appointed by the respective District Governor. Each year the Chairman will relate between the Ahepa and the Daughters of Penelope. District Legal Council to be used to work out all legal details of the mechanics of the raffle. It is suggested that the first year the appointed Chairman be Gust Aretos who has been instrumental in conceiving the establishment of a charitable

raffle. This was presented to the Daughters and came back this way:

- 1. At 2,000 tickets they say we might be biting off more than we can chew the first year until we build it up. Therefore, they suggest that we leave the amount of tickets and the way the tickets are going to be distrbuted, in other words, if only 1,000 tickets, you are going to have to cut the first prize to \$25,000, etc. and let the 8 people who are going to be put on this committee determine what they think they can do in the District during the year and come to the Fall Conference but have the authority to proceed once these 8 people decide how many tickets will go out and how many tickets they feel they can push during the year. They feel we might be able to go up to this amount but it might be more than we can chew to start off with.
- 2. The first money will be used for the Ahepa building at Saint Nicholas Ranch. They don't agree with the concept of this, they say why don't we start the first year and split right away and let us do what we want with our money and we do what we want with our money and keep it on a 50/50 basis all the way through. There is some feeling that we will work like hell the first year and the next year we don't because we have completed our Saint Nicholas project, etc. They suggest we go on a 50/50 basis and let them do what they want with the profits and we do what we want with the profits. I would like a consensus between the men that our profits go to Saint Nicholas Ranch. I would like to know how you feel about it. I would like a concensus among you that this is what you want. If we are not all in agreement it will not work. This has got to be a united project between all members. If we are not going to do it, vote against it. If you feel we ought to do it, raise your hand so that we know that we have got you behind us. We are not trying to force anyone, we are just trying to see if you people really want this because the community can not do it alone. It has got to be with your help whether we accept the concept of a District Charitable Raffle that will go on from year to year to take care of the charitable needs as At apa sees them through the years. That is the concept. Due to enough members in favor, a secret ballot was held. Strength was: District Lodge Officers 7; Past District Gobernors 14; Delegates 36; with a total of 57. Votes were in favor 39 yes, 17 no, with 1 abstained. (69% yes). Legality of the raffle was discussed.

M/S/C to adopt the concept of the raffle.

There was a motion by Brother Dakis and seconded by Brother Haramlis to have the raffle begin with 2,000 tickets.

## ANNUAL CHARITABLE PROJECTS RAFFLE of Golden Gate District #21 of the Order of Ahepa and Daughters of Penelope

It is strongly urged by the Advisory Board of Golden Gate District #21 that an ANNUAL CHARITABLE PROJECT RAFFLE be established at this District Convention, with the Daughters of Penelope as participants. The prizes will be raffled at the District Convention Banquet, starting with the District Convention of 1985.

There will be 1000 tickets issued at \$100 each. The prizes will

be as follows:

1st prize \$25,000 2nd prize \$10,000 3rd prize \$ 5,000

and nine prizes of \$1000 each

First number drawn will be the grand winner.

Total prizes \$49,000, \$1000 to be used for expenses, profit \$50,000.

Profits to be distributed each year 50% to Ahepa and 50% to the Daughters of Penelope starting with the first year. The Order of Ahepa will use the profit only for charitable projects in District #21. No monies will be used for national projects or projects outside of District #21.

Order of Ahepa profits to be used to complete St. Nicholas Ranch District project to start with. The Daughters of Penelope to use their profits for charitable projects of their choosing. District Convention delegates to decide on distribution of the factor, one year in advance.

A separate committee will be formed to administer this annual projects raffle. The respective District Governors will automatically be ex-officio members, and they will appoint 4 members from each respective lodge to administer this project each year. Besides the eight

members, a chairman will be appointed each year by the respective District Governors. Each year the chairman will rotate between the Ahepa and Daughters of Penelope. Each year the vice-shairman will rotate between the Ahepa and Daughters of Penelope.

A motion was made by Sam Dakis and Seconded by Harry Haramalis that there be a limit of 1,000 tickets rather than 2,000. The ayes won by unanimous vote. Angelo Mountanos stated that he would now report to the Daughters and report back to the assembled delegates as to the proposal.

The Convention Chairman now recognized the District Governor, George Harmas to deliver his report.

#### District Governor's Report - George Marmas

Mr. Chairman, Supreme Lodge Officers and Colleagues on the District Lodge. Past District Governors and Brother Delegates. It is with a deep sense of gratitude and appreciation that the Delegates of the 51st District Convention in Stockton afforded me the opportunity to serve Ahepa as District Governor of the 21st District. I hope that I represent the Order of Ahepa the dignity and performed by duties as District Governor above and beyond I would like to acknowledge and thank the District Lodges of the Daughters of Penelope, Sons of Pericles and Maids of Athena, for the cooperation and respect. To all the Chapters and members of District 21, thank you for the hospitality of faternalism and friendship that was bestowed to me by the District Lodge on our visitations. To the Fresno Convention community, thank you for an outstanding convention. It was exceptional. My term started in August with an excellant convention in Chicago with the ground work where this year's events took place. Then to Washington, D.C. for the District Governor's Conference. It was the mlightening event in my forty years in Ahepa. There we saw progress in order, Board of Governors in action, District Governors of the Ahepa laughters, Sons and Maids. They helped program with enthusiasm that was incredible. Then back to Washington, D.C. for the Congressional Banquet and in between installations, visitations, meetings and banquets, to give you a detailed report of meetings, phone calls and so forth, could bore you. Our time is much more valuable and we have work to do. As District Governor, you think, sleep and eat Ahepa. One cannot help but get a few ideas and recommendations for the betterment of the District. presented these recommendations to the various committees and they are working on them at this time. Ahepa is starting to work as a well organized fraternity and the Supreme Lodge is still in continuity. This has been done by organizing the Past Supreme Presidents to act as a Board of Governors and guiding the Order of Ahepa. We in District 21 have had the Past District Governors organized for years, now they too will act as a Board of Governors, Board of Directors, and guide District 21. When the District Governor needs assistance he can count on them to serve. should have committee chairman such as Travelers, Convention City, Conference, seminars, special project (Saint Nicholas Ranch) and scholar-These committee chairmen should be made known to the District Governor so if he has a problem he knows who to contact. I am recommending that the Past District Governors go on visitations with the District Lodge Officers to help regenerate some of our weaker Chapters. They have the knowledge and some of our Chapters need help. Growth and expansion: The mainstay of Ahepa is the Chapters and we in the District Lodge cannot help with one visitation per year. My recommendation is in place of a formal visitation, except for installations and initiations, to break up the District Lodge into a strong liaison unit with each District Lodge Officer responsible for two Chapters and he must visit each Chapter at least three times a year. One visitation would be made with the District Governor and the other two with a Past District Governor. After each visititation he will submit a report to the District Governor on his success and if Past District Governors were present. More can be accomplished on a one-to-one relationship instead of a formal visitation. Thus, we can help our weak Chapters. Let's try it for a year.

Any member wishing to obtain the office of District Governor should be on the District Lodge at least three years so he can aquaint himself with the District.

Better communications with the Chapters and District Lodge. All Chapters would submit such things as installations or initiations to the District Lodge prior to Convention time so it will not conflict with other visitations. The first Sunday of May has been selected by Archdiosis as Ahepa Day. Let us make an effort this coming year to make it a big day in each adminity. The District Governor should have at least one meeting with the Bishop every year thus community problems can be ironed out.

We have in our hands a form that our neighbors, District 20, uses at their conventions. It is helpful and I think we should take it into consideration and adopt it. The responsibility will be with the Convention City and placed into the Delegates packet. Ahepa booth should be considered for every church festival that is in a District with brochures and applications of Ahepa, Daughters, Sons and Maids. We have to go out and look for membership, it is obvious they are not coming to us. It was mandated that one District Conference and one seminar session with the Chapter Officers. Our first session had a little difficulty, but the conference was a success. I do recommend that the Daughters of Penelope, Sons and Maids, be aware of this through the liaison. Any legislation that includes the auxillaries should be made known to them before the convention ends so that they may adopt it. Special projects or Special Project Saint Nicholas Ranch, and recruit center is progressing very slow but surely. As of now, we are not too close to our goal of \$89,000. Some of our Chapters are dragging their feet and Brothers we have committed the Order of Ahepa so lets not back out now. The Traveler, we have a fine publication in Ahopa Traveler. Many Chapters are not sending in articles. Chapters should have a strong publicity chairman for the Traveler. National magazine andnow Greek newspapers in each community. I have received different publications from the various Districts and let me say that we should be proud of the Ahepa Traveler and

say thank you to Brother Thomas Tjovenos, the editor and his staff. Scholarship - to our Scholarship Committee, thank you for an outstanding job, expecially to our Chairman, Dr. Karl Konstantin. His eagerness, agrressiveness and dedication should be an example to us all. Let us find things to make the convention fun so that our families can participate. Backgammon is held annually by Contra Costa Chapters. Let's make a District affair with Contra Costa as our host. Let's have a golf tournament in the Valley, one in the Bay Area, play it off at the District Convention. The Legislative Dinner, last year at the Convention a plan was formed to honor the Governor of California and State Legislature. Due to circumstances beyond our control it was cancelled. We pursued it this year and the date has been set on the Governor's calendar. It will be January 23, 1985. This is the biggest event that has every happened to our Order of Ahepa in California. This event will also include District 20, and 21 and will be sponsored by the Sacramento Chapter as host. It will be held at the Holliday Inn in Sacramento.

Budget - I do know when it comes to money everyone sits up and takes notice. Well Brothers, it is money and I do hope that everyone sits up and takes notice for the following recommendations. Money should be budgeted every year so that the District Governor may attend the Congressional Banquet for

approximately \$300 per year. The District Governor of District should attend all functions or as many as he possibly can. Church, political, and Ahepa. Brothers, this takes money. We do not want to make this District Governor's office a rich man's club, because if we do we will lose a lot of good men. Therefore, I am recommending that the District Governor's allowance to the Supreme Convention be raised \$200 and the District Allownde be raised \$225. Let us have the District Governor at these functions. m honor as a true leader of District 21 of the Order of Ahepa. Overall, sistrict 21 is in pretty good shape. We have some weak Chapters and that is why I'm recommending a liaison unit of the District Lodge. I have tried to give you some of my ideas and recommendations because I feel Ahepa is on a springboard ready to take off. We have to be preprared, we can not be left in the dark. I tried to project a positive image to District because with a positive attitude nothing can stop us. All the small Dickering does not mean anything if a person thinks of Ahepa first. But, if one thinks only of glory or of himself, Ahepa is then a lost cause. So, Brothers, lets not forget what Ahepa stands for and do more in in 1984 for the greatness of Ahepa.

Mr. Chairman, I move for adoption of this report. M/S/C to adopt this report.

Addendum: One thing I did not mention. You heard the Sons of Pericles report. I did not include it in my report. I want to tell you, with the District Advisor we had this year, he did an excellent job and I want to thank Brother Harry Haramlis.

#### Thepa of the Year - George Marmas

All Secretaries received the yellow form from National Headquarters. The National sends out applications for the Ahepa of the Year. Each Chapter should have selected an Ahepa of the Year from their Chapter and presented this to the District Lodge this year for an Ahepaian of the Year for District 21 is Brother George Bezaitis. This form will go into National Headquarters and National Headquarters will select an Ahepian of the Year nationally. George, congratulations.

## Ahepian of the Year - George Bezitis

This is a complete surprise to me. I never expected any rewards for the past 54 years I have been in Ahepa. It is in my blood and what needs to be done, is done and is done in a dignified fashion and with credit to Ahepa. Never-the-less, I appreciate your consideration and I thank you very much and I hope I succeed nationally, not for George Bazaitis but for the glory of our District. Thank you.

## Election of Officers Commenced

For District Governor:

Bill Rotas nominated and seconded by Peter Kouloures, the present District Bovernor, George Marmas.

Bill Rotos, Past Supreme Govegnor -

Mr. Chairman, Lodge Delegates, Brothers. I rise before you to place in momination the name of a Brother for the office of District Governor. As you know, the job of District Governor is the most important that we have within our District. It requires not only the time of handling correspondence, doing the administrative details from an office, it requires travel.

Who has attended every solitary visitation while I've been on the District. Who has been selfless. Sometimes has been a pain in the ass but he has always been right. He has been our conscience and I have enjoyed working with him and I would ask this Convention to give real serious thought to rewarding this kind of service. Thank you.

The nominations were moved to be closed by the Chairman. A secret ballot was asked for by Andy Dakis and George Thodos, which was granted.

#### MationalProjects Report - George Bezaitis

Brothers, Delegates, this is a committee report on current National Project. First of all I want to bring your attention to Ahepa pact. This is a political action committee. This is an independent committee of the Order of Ahepa registered with the Federal Election Commission as a political action committee. The activities of the Ahepa pact are managed by six Executive members. Half are Republicans and half are Democrats. What are the goals of Ahepa Pact? Increase the impact of its national membership. The purpose of the Ahepa Pact is to gather and analyze information in raising political issues of concern to the American-Greek community and assiminate information to its members. Ahepa Pact will also provide financial and other support on a bipartisan basis, for candidates for Federal office whose positions reflect the political views of the American Greek community. There are several things. Federal Income Tax laws allow you to take a tax exempt of up to \$50 per individual. If you file a joint return you may claim \$100. Any Ahepa contributor can specify to which candidate you would like this donation to be sent. How does Ahepa Pact Committee decide which candidate to support? There are many criteria which are used by the Ahepa Pact Committee to decide which candidate will receive Ahepa Pact support. Personal qualifications for the office. The candidate

demonstrated capacity to run an effective, honest service in the office. Issue and program positions. The candidates position and record of concerns for the Greek-American community and its ability to agree on which the candidate stands and ability to be elected. Position: any particular leadership role, policy making, position or unique stature held by the candidate which makes him/her of special importance to the Greek community. This is a well organized organization. The committee recommends that the Chapters appoint a permanent committee and submit the names to Headquarters for communication between the Districts and the Supreme Lodge. I was in Washington for the last Legislative Banquet and at the meeting, they collected \$40,000 in one afternoon for the Ahepa Pact, which included my donation too.

It was moved for its adoption and passed unanimously by the delegates.

The Statue of Liberty Program - Submitted by: George Bazietis, Pete Papageorge, Gus Lekas, and Sam Dakis.

It is very important that all Chapters of our District participate with a donation towards the resotration of the Statue of Liberty on Ellis Island where millions have entered and built this great country of ours. Whether you were born here or if you came through Ellis Island, I think in reference to our fathers and grandfathers, to make a small donation towards the restoration of the State of Liberty which will cost several million dollars and for your information, which you all probably know, that the Supreme Lodge has already come forward with a check for \$100,000. I think that it would be to your own satisfaction to be able to say you made a donation towards this cause. The Annual Congressional Banquet. This banquet I was fortunate to have been there, surpassed all banquets of the past with 120 Legislators present, numerous T.V. and press media and with the incomparable Bob Hope, which was awarded the Ahepa Award after the end of the comic monologue that he gave us. The Arrangements Committee is to be commended for a magnificent job in presenting such a dignified affair befitting the occasion. Past Supreme President, Louis Manisiotis was toastmaster and was precise and to the point on his introduction. The entire affair ended at 11:00 p.m., first time in the Ahepa Banquet history. The Ahepa still maintains the Cyprus Committee and your kind help is ne-ded and solicted.

It was moved for its addoption and passed unanimously by the delegates.

#### Resolutions Committee

The Rsolutions Committee Report was given by Gus Lekas.

Be it resolved that we, the delegates herein assembled, express our appreciation through our convention chairpersons for their excellent performance, kindness, hospitality and fraternal spirit.
- 3. Whereas, our District Governor, George Marmas and his District Lodge have performed their duties in an exemplary fashion and in the finest

The Officers for the Year 1984-85 were sworn in by George Bezaitis.

#### Chapter of the Year

The Chapter of the Year was announced by District Governor George Marmas.

Brother delegates, I would like to thank you for having faith in me and re-electing me as your District Governor. I tried to create a positive image as my report said and there is still a lot of work I would like to try and complete. That is one of the reasons I ran for re-election. I have the time and I know the kind of District Lodge we have and I'll have many more meetings to try and promote these programs. There are things in the District where we con't have guidelines. We are shooting for guidelines. One of these that has been going on for years is Chapter of the Year. We propose to have guidelines to elect Chapter of the Year, which the Past District Governor's recommended earlier today in their report. As it was, it has been a process of elimination, and nominations to select a Chapter of the Year. It was difficult to choose from the Chapters that were nominated because they all had their strong points and it was difficult. Through the process of elimination we selected a Chapter and we all had the same thing in mind, to give it to a smaller Chapter. We selected Contra Costa Chapter as Chapter of the Year. We hope to present them with the plaque at the Fall Conference.

#### 4:35 Convention reconvened

Growth and Expansion Committee Report: None given.

Chairman asked that it be in the minutes that the Growth and Expansion Committee Chairman, Sam Dakis, gave no report at the 1984 Convention.

#### <u>Liaison Committee - Angelo Montanos</u> (Raffle)

Gentlemen, I was given the priviledge of going and talking to the Daughters. I told them we needed a 2/3 vote. If we did not get a 2/3 vote we would scrub the project. I told them we also, this year, felt we wanted unity and more cooperation and see if we could work together for the betterment of Ahepa and they agreed. They took their votes and they unanimously voted

to joint us in the project. Go 50/50, sell 1,000 tickets. They are going to work we are going to work. Half goes to them, half goes to us. We are going to do what we want with our money and they will do what they want with theirs.

#### For the Good of the Order

There were miscellaneous comments by the delegates and Chairman.

#### Karl Konstantin -

Brothers, for the next year, let's get together and help the District Lodge to put things in order. I think we should go back to the good old years. The Chapters elect their Delegates to the Convention and sends the names to the District. The District Secretary types these names and these names go to all Delegates. They can either pick it up with their registration or it could come to the Delegates' home. When you get here you know who the Delegates are and from what City. This should include the alternate delegates also. We should plan an agenda to follow. Therefore, we should have an agenda and the list of Delegates and Alternate Delegates and their City with the potential problems we are going to face, mailed to all Delegates before the Convention. This way we know approximately what time an event/report is going to happen. This way we can help the Chairman and we could be a little bit ahead of the game and try to do the job in a more orderly manner.

#### Lou Janakos -

I would like to comment on this too. It is extremely easy to sit at a District Convention or any meeting and find fault. We are not here to find fault, we are here to try and get organized. We have some new energetic people in our District. We have some Neophytes that are all ready to go, porking hard and charging ahead and we are sort of, in some instances, I see us re-inventing the wheel and I think what we really need, those of us that have been through it, we have never really taken the time to document. There is no business meeting takes place where you are going to be here for a weekend and there is not an agenda already prepared. We cut our Convention times now down to two days, Friday and Saturday. I think in some instances we really need that extra half day to get the committees organized and to get that time together and then we can proceed. What we have set ourselves up for, as I see it, is that we have to put all this work into two days and consequently it cuts into our family's entertainment time and the project time and then we are faced with overhead and cost and an extra day at the hotel. We may be being pennywise and penny-foolish. I said it last night at the District Governor's meeting and I'm saying it again today. We are seeing a surge of energy being interjected into the Order of Ahepa but that surge of energy is beginning to run ahead of the protocol. We certainly don't want to stop it and we certainly don't want to deter it but we have to harness it. I really feel strongly about the fact that the District Lodge should be a District Lodge. I feel that the ties and the jackets and the protocol that you follow when you come to a Chapter visitation. Here we are at a convention, if there is any place where you represent yourselves to the Sons, to the Daughters, to the Maids, to everyone in the community, the general public at large, this is the place and this is the place where we should start to regain control of the protocol, the dress. This is not a criticism, it is really an observation and I think there is a need, especially to generate to the Neophytes that the people who are in control of the Order of Ahepa knows what they are doing, are capable people and as it was said last night, we should

project an image that those people want to aspire to and I think for this year, if I had to talk on a one-to-one basis to the District Lodge, this is what I would say. Let's get some protocol, let's shape it up, and move it back to some tradition but by no means cut the enthusiasm of the new people here.

### Budget Report

A lengthy budget committee report was given by Spiron Tentes.

The budget process takes several hours. We met yesterday afternoon. We continued this morning after 11:00 a.m. and continued this afternoon and just finished it. First of all I would like to name the Committee. They all contributed a great deal. First is Arnold Dorer. He brought his computer here. A lot of you saw it. He has put out some good results and I think we are going to have some fantastic reports in the future. He is going to take the drudgery out of manual bookkeeping for the District and the Chapters. We are going to devise a program so that when any report is given, you can have a copy in your hands right away. When the Chairman calls up a Chairman, you can see it, draw conclusions and act intelligently. Also, other members were Ernest Kageones, George Hontalas, Gus Hontalas, Nicholas Vavuris, Steve Scorkes, George Thodos, Louis Colombotos and James Koplos. Bill Rotos, our District Auditire and perimial advisor was also present. I am going to give you the budget figures in summary. If someone wants more information, raise your hand and I will give you more details.

General Fund - I am not going to give you the actual figures, I assume Brother Rotas gave them to you earlier. We take last year's budget, we take the actual the District Lodge has done and they have done a fair job. We had a surplus of \$1,174.00. Based on those figures and the recommendations here are the findings and unanimous conclusions of the Committee which represents the majority of the Chapters in the District. The revenue on the budget for the general fund \$4,490. The revenue sources are: per capita tax for Supreme Lodge, per capita tax for District Lodge, District Convention proceeds, rebates from the Supreme Convention Delegates, the Reno excusion which is 50% share and interest in our savings accounts total \$4,490. Disbursements in the general fund amount to \$4,125 and assuming the budget is maintained, we don't go over budget, we will have a surplus of \$365. The disbursements consist of District Governor's District Allowance increased from \$575 to \$600. We did away with individual allowances and made it the District Officers Travel Allowance to be handled and disbursed by the District Governor after he knows that these various District Officers traveled to the various Chapters. We have allocated \$1,200. It is the same as last year except we lumped it together and we are telling the District Governor that it is his responsibility to see that these officers are traveling. If they don't travel, they don't get paid. When he comes in next year he has to tell us just who he paid, who traveled. What I'm getting at is, I am sure you don't want to pay someone who doesn't travel. District Adultor's allowance was increased \$25 to \$125. He does a lot of work. Sons of Pericles allotment we left the same \$600. Computer service of \$200. We are not buying buying software, hardware, or computers. We are only paying for supplies that Brother Dorer is using. He is using his own computer. He is not charging us anything. He is doing it for the love of the Order and I think he deserves a great hand. Brother Chairman, I move for adoption of the General Fund Budget.

There was much discussion against the proposal for the travel allowance to be the responsibility of the District Governor. Many felt strongly that officers should each have their own allowance.

A motion was made by Bill Rotas that the allowances for the District Lodge, the 5 elective District Officers, revert back to the amount of money that was appropriated in prior years

by position, which is \$195 a year allowance. That we also go back to the \$225 allowance for the Lt. District Governor as we have had it in previous years.

K. Donstatin seconded the motion.

M/S/C to accept this report with the exception of Item #4, it would remain unchanged from last year's guidelines.

M/S/C to increase the Sons of Pericles budget from \$600 to \$800.

M/S/C to add District Chaplain and Advisors allowances of \$195 each.

M/S/C to adopt the General Fund with the amendments voted upon.

Ahepa Traveler Fund - Revenue from Item #1, Assessment from District Lodge. We have this budget at 850 members. We have had lousy reporting, lousy accounting. If they had done commercial accounting they would get fired as bookkeepers. They wait until the last minute to present it. How can Brother Rotos do an accounting? We just can't have that. We have a cut-off date of May 31st. This has always been a problem but we are trying to resolve 850 members is an estimated figure. Before the money came in it was way down around 600 people. It looked like Brother Marmas and the District Lodge dropped in membership substantially, which they did not. It was just we did not have the money, the paid up members. We will have the paid up members in the next few weeks. We give \$2.50 per capita tax for each projected member. Item #1 is \$2,125 projected on the budget. The assessments with the Daughters of Penelope \$1,000. Advertising \$1,000, revenue dropped this year. Raffle - we did not budget anything because there is no raffle going on. We budgeted \$100 from the Scholarship Committee. The Scholarship Committee used a full page. This was discussed with Dr. Konstatin and \$100 a year is not too much for the Scholarship Committee. Expenses are going up and revenue is going down. We have to go after money, unless we transfer funds from the General Fund into the Traveler Fund. This give a total estimated revenue of \$4,975 leaving a surplus of \$250. Printing expense, we budgeted \$3,000 last year and it went up to \$3,089. We talked to Brother Javines, he said no substantial increases in publishing expenses but they have all crept up. On the allowances for the editor and allowance for Circulation Manager, they are the people who work hard, unsung heros, no glory attached to it. They do it away from everyone else, they don't do it for a crowd, so we raised the allowance for the editor to \$125 and the Circulation Manager to \$100 for their expenses. Addressing the Traveler last year we budgeted \$100, expenses were 193, almost double our budget. We increased the budget to \$200. The mailing ex-enses also increased from \$400 to \$445, we budgeted \$450. We may get another rate increase from the Post Office, we don't know. That brings us down to \$3,975, as I said before, it gives us a surplus of \$250, assuming these figures are fairly Therefore, Brother Chairman, I move for the adoption of the Traveler Fund Budget Report.

M/S/C that Scholarship Committee will not be assessed for putting information in the Ahepa Traveler.

M/S/C to reduce the budget by \$100.

M/S/C to adopt the Travelers Budget with amendments.

M/S/C to adopt the Travelers Report including the exceptions.

Chairman stated that Donna Love should be recognized as Executive Secretary, She sat here very patiently through a long discussion that was of great interest to all of us but it's all Greek to her. From the floor it was felt that this particular action be put in the minutes.

### Good of the Order

Nick Loumis reported to the Convention on a donor for the Sons of Pericles. It was declared by Deno Alexander, a member delegate from Contra Costa, Chapter 259, that he would pledge \$5,000, given at \$1,000 a year for five years through the sale of his two books which are soon to be published. His donation will be given to the Sons of Pericles for their financial support in their activities.

#### Nick Loumis:

Mr. Chairman, Brothers, I have a very important announcement to make that will please you all. Our good Brother Alexander from Contra Costa, Chapter 259 approached me outside and said he was impressed with the questions and interest the Chapters have shown for the Sons of Pericles. He was very impressed with the young men who came here and who are very sincere in building a good foundation for the Sons of Pericles of this District and he has come up with this very amazing offer. He is willing to donate each year \$1,000 for five years to be used exclusively for the Sons' activities. This means that we are getting \$5,000 from one individual that wants to see the Sons of Pericles grow. I am very grateful for this wonderful Brother. I want to say to you, I see some of you smiling. I think they are smiling because they are so happy that someone is contributing \$5,000. I am happy they are smiling but if they are smiling for some other reason, I feel sorry for them. There is only one catch. This money is coming from a book he is publishing. I am going to ask Brother Alexander to come up here and give us his own opinion because this is going to revolutionize the work of the Sons in our District. Do you realize that if we get \$1,000 in for the Sons, we won't need anything in the budget. We will have enough to take care of them for five years. I really think the only question here is the mechanics. Unfortunately, I don't believe we have enough time to legislate or pass upon this. My obervation is that it should be donated or put into a form of a trust of a committee of three with the District Governor the I want to find out whether Brother Alexander could make this contribution without the conditions that it come from the book. to say that this is a wonderful, wonderful feeling that this man has for our Sons and our District.

#### Deno Alexander -

Brother Ahepians, I have a feeling and I think it is my duty and responsibility to do what I can, not just for our Chapter but throughout the world. The reason I am doing this, I came to this country with the help of my uncle, Manuel Alexander, and also with the help of the Ahepa. Now I feel with the help of my uncle and the Ahepa I am here in this beautiful country. I have written a book and I have sold it. Some have been delivered to me and by September 30th I expect to get a considerable amount. I instructed my attorney to take 75-80% to put in a trust account to help not only my native country Sarmos but to also use my judgement as to who needs help. I am committing myself to \$1,000 through a trust account through my attorney on or before the first day of October for five consequtive years to start with. If I make more I will give you my word I will give more. Not to the Sons of Pericles but to the other different committees we have. I have written two books already that have been published. They are Events of an Immigrant and Miriam. My desire is to go back to Sarmos and build a hospital.

### George Marmas -

I suggested to the Growth and Expansion Committee that election of officers should be late in the day. If we have elections at 1:00 p.m. as mandated many of the people day, elections are over, we are gone. That hurts the Convention City. If we hold them later in the day, say 5:00 or 6:00 p.m. chances are more people will stay for the evening function.

It is with a deep sense of gratitude and appereciation to the Delegates of the 51st District Convention in Stockton for the opportunity they offered me to serve Ahepa as District Governor of the 21st District. I hope that I represented the Order of Ahepa with dignity and preformed my duties as District Governor above and beyond reproach.

I would like to acknowledge and thank the District Lodges of the Daughters of Penelope, Sons of Pericles, and the Maid of Athene for their cooperation and respect.

To all the Chapters and members of District 21, "Thank You "for the hospitality, fraternalisim and friendship that was bestowed to me and my District Lodge on our visitations.

To the Freemo Convention Committee " Thank You "for an outstand-ing Convention.

Finally to my District Lodge "Thank You "for your effort, your time and your cooperation. It was expectional.

Ty travels started in August with the National Convention in Chicago where the ground work for this years events took place, then to Washington D. C. for the District Governors Conference. It was the most enlightening event of my 40 years in the Ahepa. There we saw progress in the Order, Board of Governors in action District Governors of the Ahepa, Daughters, Sons, and Maids laying out programs the enthusiasm was incredible. Then back to Washington for the Congressional Banquet and in between, installations, visitations, meetings, and banquets. To give you a detailed report of meetings, phone calls, etc, would bore you. Our time is much more valuable, and we have work to do.

As a District Governor you think, sleep and eat Ahepa. One cannot help but got a few ideas and recommendations for the betterment of the District. I have presented these recommendations to the various committees and they are working on them at this time.

Ahepa is starting to work as a well organized fraternity as the Supreme Lodge:

is showing continuity. This has been done by organizing the <u>Past Supreme Presidents</u> who are acting as a Board of Directors and Guiding the Order of Ahepa.

We in District #21 have had the PAST-)ISTRICT-GOVERNORS organized for years. Now, they too will act as Board of Directors and guide District #21. When the District Governor needs assistance he can count on them to serve. They should have Committee Chairman: such as Traveler Chairman, Convention City Chairman, Conference and Seminars, Special Projects, such as The St. Nicholas Ranch and Scholarships. These committee chairman should be made known to the District Governor...so if he has a problem he knows whom to contact.

I am recommending that the Past District Governors go on visitations with a District Lodge officer to help regenerate some of our weaker chapters. They have the knowledge and some of our Chapters need help.

### GROWTH & EXPANSION

Lodge cannot help on one visitation a year. My recommendation in place of a formal Visitation except for Installations and Initiations to break up the District Lodge into a strong liaison unit with each District Lodge officer responsible for two chapters and he must visit each chapter at least three times. One visitation will be made with the District Governor and the other two with a Past Distr. Governor. After each visitation he will submit a remort to the District Governor on his success and if a Past-Distr.—Tov. was present.

More can be accomplished on a one-to-one relationship instead of a formal visitation...thus we can help our weak Thapters. Let us try it for a year.

- 2. Any member wishing to attain the office of District Governor should be on the District Lodge at least three (3) years so he can acquaint himself with the District.
- 3. Better communication with Chapters and the District Lodge. All Chapters should submit there wants, such as Installation or Initiation to the District Lodge at the Convention.... so it will not conflict with may other visitations.
- 4. The FIRST WODAY OF LAY has been selected by our Archdiocese as AUEFA DAY....let us make an effort to make it a DIF DAY in each community this coming year.
- 5. The District Governor should have at least OTE meeting with the Bishon every year thus community problems can be impred out.

- twenty (20) uses at their Conventions. It is helpful and I think we should take it into consideration and adopt it....the responsibility will be with the Convention City and place into each delegates pack.
- 7. Ahena Booths thould be considered for every Thurch Festival that is in our District with brochures and applications of Ahena, Daughters of Penelope, Bons of Pericles and Maids of Athena. We have to go out and look for memberships. It is obvious, that they are not coming to us.
- Seminar Jession with Thapter Officers. Out first session had a little difficulty but the Conference was a success. I do recommend that the Auxillarys, the Daughters of enelone, Sons and the Maids be made aware of this thru the liaison. Any Legislation that includes the auxiliarys SHOULD BE MADE KNOWN TO THEM before the Convention ends so that they may adopt it.

### SPECIAL PROJECTS

Our Special Project, St. Nicholas Ranch and Retreat Center if progressing very slow BUT sure. As of new, we are TOT too close to our goal \$89,000. Some of our Chapters are dragging their feet and brother, WE HAVE committeed the Ahepa.... so let us not back down NOW.

### TRAVELER

We have a fine publication in the Ahepa Traveler. Many Chapters are not sending in any articles. Each chapter should have a strong publicity chairman for the Traveler, National Magazine and Non-Greek papers in each community. I have received different publications from various Districts and let me say....that we should be proud of the Ahepa Traveler and say "THANK YOU" brother Tom Tjovenos, Editor and his staff.

### SCHOLARS IF

To our scholarship committee THANK MOU for an outstanding job, especially to our Thairman, Dr. Karl Monstantine... is eagerness, aggressivness and dedication should be an example to all of us. We are roud to have a man of his caliber to head this committee. THANK YOU Dr. Konstantine and your committee.

## SETTIMOT DITEMETA

I have recommended we have an Athletic Committee at each Convention to plan events amongst chapters and District events should be Golf Tournaments, Bowling--- may be Caseball with our Sons... let us find things to make a Convention fun... so our families can participate. Bakgamon is held annually by Contra Costa Chapter. Let us make it a District Affair with Contra Costa as our Host!! Let us have a golf tournament in the valley and one in the Bay area....Play it off at the next District Convention.

## LEGISIATURE DINNER

Last year at the Convention a plan was formed to honor the Governor of California and the State Legislaures. Due to circumstances beyond our control, it was cancelled. We pursudd it this year and the date has been set on the Governor's calender...it will be on January 28, 1985. This is the biggest event that has ever happened to our Order of Ahepa of California. This event will also include District #20 & #21 and will be sponsored by the Sacramento Ahepa Chapter...it will be held at the Holiday Inn of Sacramento.

### \_BUDGET

I do know when it comes to MONEY every one sits up and takes Notice...Well Brothers, IT IS MO EY, and I do hope every one sits up and takes notice for the following recommendations:

1. Money be budgetted every year so that the District Governor attend The Congressional Banquet approximately \$300.00 a year.

2. The District Governor of a District should attend ALL FUNCTIONS or as many as he can whether Church, Political or Ahepa. Brothers, this takes money. Je do not want to make the District Governor Office A "Rich Man's" Club, because if we do, we will lose a lot of Good Men; therefore, I am recommending:

That the District Govvernor allowance to the Supreme

Convention be raised \$200 more.

His District Allowance be increased \$225.

Let us have the District Governor at these functions and honored as a true Leader of District #21 Order of Ahepa.

## DISTRICT

Overall District 21 is in pretty good shape, we do have some weak chapters and that is why I am recomending the liaison unit of the District Lodge.
